



## KeBeK Private Equity reaches an agreement on a successful exit of its stake in Lunch Garden

Strombeek-Bever, 10-12-2015 – Bregal Freshstream becoming the new owner of Lunch Garden was announced during an extraordinary works council at the company. The new owner, a London based private equity fund, would like to thank the previous owners for the efforts that were made in recent years and expresses its ambition to grow Lunch Garden.

The ownership of the Belgian restaurant chain Lunch Garden changes after a period of more than five years. The current owners (H2 Equity Partners, KeBeK Private Equity and Solferino Holding NV) and Bregal Freshstream have reached an agreement regarding the sale of the company. Bregal Freshstream is a private equity fund based in London. The transaction is still subject to regulatory approval by Belgian authorities.

Over the past five years of Lunch Garden was repositioned. More than € 50 million was spent on the modernization of the existing restaurants and the opening of several new restaurants. In addition, a partnership with Total regarding the exploitation of road restaurants was set up, a new marketing plan was implemented and a new collective labor agreement was negotiated. These changes have made the company ready for the future.

Bregal Freshstream would like to thank the previous owners for these important efforts. They aim to further grow Lunch Garden. In this respect a new growth strategy will be developed together with management.
